**Staff report** will be available at least seven days before the hearings at <a href="www.tualatinoregon.gov/meetings">www.tualatinoregon.gov/meetings</a> for inspection at no cost, and printed copies will be provided at a reasonable cost.

Individuals wishing to comment on the application(s) must do so in writing to the Planning Division prior to each hearing, or in writing and/or orally at the hearing. The minimum statutory comment period is 21 days for these applications; the deadline for materials to be received to be included in the hearing packets for the respective applications has been <u>extended</u> to <u>August 6, 2025</u> for IMP24-0001 and <u>August 27, 2025</u> for AR24-0002.

**Each public hearing will begin** with a staff presentation, followed by testimony by proponents, testimony by opponents, and rebuttal. The time of individual testimony may be limited. If a participant requests, before the hearing is closed, the record shall remain open for at least 7 days after the hearing.

All citizens are invited to attend and be heard: Failure of an issue to be raised in the hearing(s), in person, or by letter, or failure to provide sufficient specificity to afford the decision maker(s) an opportunity to respond to the issue precludes appeal to the State Land Use Board of Appeals (LUBA) based on that issue. The failure of the applicant to raise constitutional or other issues relating to the proposed conditions of approval with sufficient specificity to the applicable hearing body maker to respond to the issue precludes an action for damages in circuit court.

**Notice of the Decision for each decision** will only be provided to those who submit written comments regarding *that* application and/or testify at the hearing on *that* decision.
